REGISTRATION TERMS & CONDITIONS

- **Payment & VAT**

In accordance with Dutch and European law, Dutch VAT must be charged on fees for events held on-site in the Netherlands from all participants originating from in and outside of the EU.

Tax payers established in the Netherlands (with Dutch VAT number) are subject to Art. 194 VAT Directive (reverse charge). They will not be charged on the invoice and will arrange the tax payments directly through their declaration.

All delegates are advised to arrange for full payment prior to the event to avoid any delays in collecting their badges and on-site material. No badges and materials will be issued to delegates with an outstanding payment.

- **Registration Categories**

The Research Reactor Conference (RRFM) 2026 offers reduced registration rates for delegates belonging to the following registration categories:

- ENS Members: applicable to Members of [ENS' Member Societies](#)
- Reduced Rate: applicable to employees of Universities

Unjustified registrations under those reduced categories will be cancelled or moved to another category. Any applicable financial cost will be borne by the delegate. Exceptions may be granted by the organiser on written request.

Special rates and reductions are furthermore available for the following categories:

EUROPEAN RESEARCH REACTOR CONFERENCE

- Young Generation: applicable to members of the ENS Young Generation Network
- Participants of the RRFM 2026 Student Contest
- Sponsors and exhibitors: complimentary access for sponsors as agreed in a RRFM 2026 sponsoring or exhibition agreement

Two side events will be held at the occasion of RRFM 2026: IRIS 2026 and SMaRRt 2026. It is possible to register for both events separately.

- **Cancellation**

For cancellations of registered delegates received in writing by 27 March 2026 midnight CET, the registration fee will be refunded (net of bank or credit card charges). No refund can be made for any cancellation received after that date.

- **Substitutions**

A paid registrant can be replaced by a colleague provided that the organisers receive all information by email by 10 April 2026. This substitution will not incur any cost, except if the person replacing an ENS member is not a member.

Travel and Transportation

All delegates are responsible for arranging their own travel, accommodation, and transportation. Please note that citizens of some countries are required to obtain visa prior to arrival. Please consult with a nearby Dutch consulate or embassy.

The organiser is not responsible for any travel, accommodation, transportation, or visa matters for delegates. Delegates are responsible for their reservation.

LIABILITY

- **Event Programme Change**

For organisational reasons, and/or reasons beyond the control of ENS, ENS reserves the right to alter the timing and content of the programme without prior notice at any time before or during the event.

- **Event Cancellation, Insurance, and Liability**

In the case of government intervention or regulation, military activity, strikes, or any other circumstances that make it impossible or inadvisable for the Research Reactor Conference (RRFM) 2026 and its side events to take place at the time and place provided, the delegate shall waive any claim for damages or compensation except the amount paid for registration after deduction of actual overhead expenses incurred in connection with the Research Reactor Conference (RRFM) 2026 (comprised of the venue and service providers non-refundable deposits, etc.) and there shall be no future or derived/indirect liability on the part of either or any party. All delegates take part in the event at their own risk and are encouraged to obtain adequate coverage for travel, health, and accidental insurance before they depart from their countries. The organisers, their suppliers, or agents accept no liability for any personal injuries, or loss of, or damage to, private property belonging to the Research Reactor Conference (RRFM) 2026 delegates.
